About the Bay Village Foundation

The Bay Village Foundation is dedicated to preserving the quality of life in Bay Village, Ohio, using the talents and resources of its citizens and non-government funding.

The Foundation exists to provide support for projects, programs and scholarships fostering Bay Village's historical, cultural, social, and educational heritage. History

In 1995 a group of civic-minded volunteers established a fund to help the city build a playground. The project was called, Play-in-Bay. The playground project was a cooperative effort of nonprofit organizations that worked together to see it through to completion.

With this successful collaborative effort, a small group decided to develop a sustainable community fund that would be available as other projects like Play in Bay emerged.

Under the leadership of T. Richard (Dick) Martin, they worked to create an organization to which others could look for financial support. It took several years to see this dream become a reality, including many volunteer hours. The fund is now known as The Bay Village Foundation.

Community Grants

The Foundation is primarily focused upon supporting capital projects that improve the quality of life in the City of Bay Village. Projects must be responsive to community needs. The Foundation will also consider requests for support of programs that benefit the citizens of the City of Bay Village.

To be eligible, an organization must be located in or provide services to residents within the City of Bay Village. Funding will only be awarded to tax-exempt organizations classified as 501(c)(3) charities by the Internal Revenue Service, or programs that have a tax-exempt fiscal agent.





Scholarships

The Foundation scholarships are awarded annually to graduating high school students residing in Bay Village.

Scholarship recipients will possess a vision for improving and enhancing the quality of life in Bay Village, and must outline a proposed project to the Foundation for possible implementation in the future.

Giving

Donations to the Foundation preserve the quality of life in Bay Village, support our institutions and students and are tax deductible. Run exclusively by volunteer directors representing a diversity of professional backgrounds and experiences, you are invited to join them as donors to the Foundation.
